- 1. Tender Applications received after the specified date and time will not be accepted.
- 2. Tender Applications received through Registered Post with Acknowledgement Due /Courier within the above time limit will also be accepted. Co-optex is not responsible for any delay in transit.
- The Tenderer must quote their GSTIN No. at the space provided in the Tender document and must produce valid proof for GSTIN No. and copy of PAN Card.
- 4. Tender should be sent in the prescribed form only, duly signed by the tenderer..

- 12. No Advance Payment shall be effected. Payment shall be made only on completion of entire supply and after receiving test report for colour fastness and fabric quality. The testing charges shall be borne by you.
- 13. If any supply don't meet required specification and colour fastness. Such bags will be rejected and returned to the Tenderer at their cost.
- 14. The No of stitches in the bags should be 12 per inch.
- 15.Income Tax will be deducted as per IT rules in force, while effecting payment, for which xerox copy of PAN Card should be enclosed along with bill.
- 16.Additional quantity if any required for the year 2018-19, shall be supplied by the Tenderer at the same rate.
- 17. The tenders should be accompanied by an Earnest Money Deposit of Rs.5,000/- by crossed Demand Draft / Banker's Cheque in favour of "The Tamilnadu Handloom Weavers Co-operative Society Limited" drawn in any scheduled bank payable in Coimbatore City purchased from 12.11.2018 to 19.11.2018 and tender which are not accompanied by the prescribed Earnest Money Deposit will be summarily rejected.
